

NOTICE OF MOTION

Date of Council meeting at which motion to be considered: 27 June 2016

BACKGROUND:

I am interested in ensuring our rating structure is as effective as possible.

OBJECTIVE:

Considering that properties in Marlow Lagoon are in some ways unique within Palmerston, due to size of allotments and constraints due to biting insects and inundation, I believe that establishing a separate rate for Marlow Lagoon residential properties would be an effective method of rating.

Section 148(3)(a) identifies that Council is able to rate allotments based on their location. I propose that a Marlow Lagoon UCV based differential rate be established and set at 0.350971% for 2016/17, with a minimum rate set at \$1,177 (excluding waste charge, which shall remain the same as the rest of the city). The effect of this change is such that Council will raise \$34,156 less than budgeted, which I believe can be handled within the 2016/17 budget.
