Summary:

This report provides the Community, Culture and Environment Committee (CCE) with an application received for financial assistance through the Community Benefit Scheme and seeks the Committee's recommendation to Council.

Background:

Melaleuca Refugee Centre together with Multicultural Council of the NT propose to provide a World Refugee Day Festival, based in Palmerston. This community event, to be held in Goyder Square, will include food, dance, performance and sport. Some of the lead-in activities involve training for participants.

Melaleuca Refugee Centre requests support in the form of \$20,000 sponsorship to provide the World Refugee Day Festival event.

General:

The Community, Culture and Environment Committee who meet on a monthly basis will assess applications for Grants/Donations/Scholarships/Sponsorships that are in excess of \$2,000 and make recommendation to Council.

Financial Implications:

The financial implications to Council, should the Committee recommend funding, would be \$20,000 from the Community Grant Reserve. Funds would be transferred in the third Budget Review as operational budget for 2015/16 has been exhausted.

Every year Melaleuca Refugee Centre (Melaleuca) has organised a World Refugee Day Festival as part of World Refugee Week. This year Melaleuca Refugee Centre and the Multicultural Council of the NT (MCNT) are taking joint responsibility for the event. We are interested in strengthening our relationships with Palmerston communities and encouraging new participants by holding the event at Goyder Square and possibly other council venues such as the library and recreation centre.

The event aims to celebrate the resilience, talents and achievements of people from a refugee background in the Northern Territory. The resounding feedback from refugee communities in consultations this year has been that they want to be involved in an event that showcases their talents, enables them to participate actively and 'give back' to the broader community through their cultural expressions in food, dance, performance and sport. The event includes training for community members to provide ongoing employment opportunities after the event.

Melaleuca acknowledges the commitment of The City of Palmerston declared Welcome Refugee Zone. Melaleuca and MCNT in line with this are seeking to stage World Refugee Day event in partnership with the City of Palmerston. We are seeking \$20,000 from the City of Palmerston. Melaleuca has gratefully received funding from NT Government to fund a part time, temporary World Refugee Day Coordinator. Melaleuca and MCNT bring considerable experience, skills, networks and staff time to the event. Other key organisations such as Football Without Borders, Anglicare NT, Red Cross, Relationships Australia have been active planning group members of past events and represented along with 40 community members at the recent World Refugee Day consultation for 2016. Service providers will also be invited to participate and offer activities.

- Expressing welcome and embracing people from refugee background
- Building productive and collaborative relationships between migrant communities and the broader Darwin community to increase inclusiveness within the broader community and appreciation of the added value and richness of diversity
- Building the skill and capacity of newly arrived populations to better access the workforce and participate in the economy of the NT
- Opportunity for newly arrived people to develop and practice new language skills through participation
- Active promotion of refugee participation in Australian life
- Collaboration across mainstream and migrant organisations
- Breaking down feelings of social isolation amongst vulnerable persons
- Breaking down of stereotypes, fears and negative media addressed toward people from refugee background

With the commitment of the NT Government to welcoming Syrian refugees, many of whom are anticipated to be resettled in Palmerston and Darwin, we believe it is even more important to ensure that World Refugee Day is celebrated well in the NT to highlight the positive contributions of refugees to our community.

As a Council already participating in the Refugee Welcome Zone program, the City of Palmerston is ideally placed to host World Refugee Day. The Festival is a beacon of hope, aspiration and celebration, and should not be underestimated as a positive message of welcome for refugees in our community.

We look forward to your favourable and prompt response to this request given that the event will be celebrated on 18 June, in nine weeks' time.

We have audited the accompanying financial report, being a special purpose financial report, of the Melaleuca Refugee Centre Torture & Trauma Survivor's Service of the Northern Territory Incorporated, which comprises the balance sheet as at 30 June 2015, and profit and loss statement for the year then ended, a summary of significant accounting policies, other explanatory notes and the statement by members of the Management Committee.

The Responsibility of the Management Committee for the Financial Report

The Management Committee of the Association is responsible for the preparation and fair presentation of the financial report and have determined that the accounting policies described in Note 1 to the financial statements which form part of the financial report are appropriate to meet the financial reporting requirements of the Associations Act and are appropriate to meet the needs of the members. The Management Committee's responsibility also includes establishing and maintaining internal controls relevant to the preparation and fair presentation of the financial report that is free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances. These policies do not require the application of all Accounting Standards and other mandatory financial reporting requirements in Australia.

Auditor's Responsibility

Our responsibility is to express an opinion on the financial report based on our audit. No opinion is expressed as to whether the accounting policies used, as described in Note 1, are appropriate to meet the needs of the members. We conducted our audit in accordance with Australian Auditing Standards. These Auditing Standards require that we comply with relevant ethical requirements relating to audit engagements and plan and perform the audit to obtain reasonable assurance whether the financial report is free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial report. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Management Committee, as well as evaluating the overall presentation of the financial report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

In conducting our audit, we have complied with the independence requirements of the Australian professional accounting bodies.

Auditor's Opinion

In our opinion the financial report presents fairly, in all material respects, the financial position of the Melaleuca Refugee Centre Torture & Trauma Survivor's Service of the Northern Territory Incorporated as of 30 June 2015 and of its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the Associations Act.

Basis of Accounting and Restriction on Distribution

Without modifying our opinion, we draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the Melaleuca Refugee Centre Torture & Trauma Survivor's Service of the Northern Territory Incorporated to meet the requirements of the Associations Act and the Association's constitution. As a result, the financial report may not be suitable for another purpose.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Constitution and the Northern Territory Associations Act. The Management Committee has determined that the Association is not a reporting entity, because in the Management Committee's opinion there are unlikely to exist users who are unable to command the preparation of reports tailored so as to satisfy all of their information needs.

This financial report is therefore a special purpose financial report that has been prepared to meet the requirements of the Northern Territory Associations Act and Regulations and the Association's Constitution.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this report.

(a) Statement of Cash Flows

The Association does not prepare a statement of cash flows as required by AASB107. The Association believes there is adequate relevant information available from the financial report, and therefore the omission of the statement of cash flows does not adversely affect:

- (i) decisions about the allocation of scarce resources made by the users of the financial report, and
- (ii) discharge of accountability of management and committee of management.

(b) Property, plant and equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation. The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

The rates used are: Motor Vehicles: 16.67% - 30% (2014: 30%) Building renovations: 8.33% (2014: 8.33%)

(c) Income Tax

The Association is a Public Benevolent Institution with all applicable taxation exemptions.

(d) Employee entitlements

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee entitlements have been measured at the amounts expected to be paid when the liability is settled.

(e) Provisions

Provisions are recognised when the Association has a legal or constructed obligation, as a result of past events for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(f) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(g) Revenue and Other Income

Revenue is measured at fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue. All revenue is stated net of the amount of goods and service tax. Interest revenue is recognised using the effective interest rate method.

Grant and donation income is recognised when the Association obtains control over the funds, which is generally at the time of receipt. The portion of grant income received in the current year that remains unspent at year end is transferred to current liabilities in the balance sheet. Contract services income is recognised when invoiced and fees not received yet will reflect as receivables in current assets.

(h) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST. Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount receivable or payable to the Australian Taxation Office is included with other receivables or payables in the balance sheet.

(i) Expenditure for Humanitarian Settlement Services

Under the terms of the contract with the Department of Immigration and Border Protection (DIBP) amounts paid to legitimate Australian citizens for the purchase of household furniture and transit accommodation expenses are not recorded as non-current assets in the books of the Association. The disbursements are treated as general expenditure and are tracked or substantiated through the documentation.





3.2 Assets and Infrastructure

3.2 We are committed to maintaining and developing community assets and infrastructure which meet the needs of our community

Summary:

Power Water Corporation (PWC) is planning to construct a new (replacement) 132kv electrical transmission line from the Palmerston side of Elizabeth River to the Weddell side and continuing for several metres.

The PWC seeks Council consent to access and construct the power line on lot 4192, Archer.

General:

The power line traverses sections 1817 (VCL), 4192 (City of Palmerston), 8403 (railway) and 4259 (VCL). Attachment A

Lot 4192 is a 13.26Ha parcel of land with a 276m frontage to Elizabeth River. The parcel is roughly rectangular in shape with a small triangular electrical easement off the eastern boundary. The lot is zoned organised recreation (OR) **Attachment B.**

The PWC seek to establish an easement over lot 4192 approximately 35m wide adjacent to the eastern boundary. Total area of the required easement is approximately 12,500m². **Attachment C**. The PWC requires the easement for overhead services. The ground clearance to the electrical infrastructure required would be 8m.

Financial Implications:

While lot 4192 is currently zoned OR there doesn't appear to be any reason why rezoning to a more commercial zone would not be considered by the Minister for Lands. Locations within the lot, including the proposed easement, could be utilised for maritime uses such as a small marina or ferry terminal, ship repairs, or retail.

The UCV of the lot is \$485,000. Given the location of the property and the potential for other services that may be required to cross Elizabeth River in this area Council may seek to sell the property to PWC.







construct, inspect and maintain an asset which stands on private property, and to regulate the activities of others within the easement to ensure the safety of all people and safe and reliable operation of the asset.

6.2 Easements for Overhead Lines

The needs related to overhead lines are:

- access for construction and inspection
- cleared space to prevent accidental contact with trees in high winds
- access for reconstruction or repairs where necessary.

Overhead lines need to be patrolled and inspected, often from Elevating Work Platform (EWP) vehicles. During construction or major repairs such as pole replacement, even larger vehicles, such as crane / borer vehicles, may be used to erect line supports.

The easement width needs to be sufficient to facilitate control of vegetation that is potentially likely to contact conductors. Refer to Network Policy NP 013 *Management of Vegetation Near Overhead Power Lines.*

Current Power and Water policy is based on the following easement widths:

For 66, 132 and 275kV lines, it is common to establish transmission "corridors" which are designed to take two or more lines in ultimate configuration. Consequently, it is often the case to find that single circuit lines have quite large easements, to cope with future lines.

As well as securing access to the line, Power and Water has the responsibility of keeping trees and other objects far enough from the wires to avoid accidental contact. For this purpose there is a standard buffer zone within which trees will be felled or trimmed as necessary and this is illustrated in Drawing Number S1-4-1-4 (see Appendix A). In addition an area of 2 m radius around supporting guys will be cleared of all vegetation.

6.3 Activities within Overhead Line Easements

Some activities and developments may be carried on within overhead line easements without risk to personal safety or line integrity. These are classified as *Permitted Activities*.

- installation of irrigation equipment provided no part of the equipment exceeds 4.0 m in height and no solid jet of water can come within 3.0 m of line conductors. Water jets must be such that they cannot cause conductor clashing.
- erection of electric fencing up to 2.5 m in height provided it does not pass beneath the line
- installation of other services such as water, telephone etc. provided safe working clearances are maintained and due consideration is given to the risk of induced voltages
- construction of roads provided design clearances are maintained (see Drawings S1-4-1-2 and S1-4-1-3)
- construction of dams and creation of bodies of water
- burning off or lighting of fires
- conduct of sporting and recreational activities which cannot, even by misuse, constitute a hazard to the line or persons
- Wherever controlled activities are approved but their implementation is subsequently found to not comply with the terms of the approval, or create a hazard or impediment, action shall be taken to rectify the situation.

6.3.3 Prohibited Activities

The following activities are prohibited in overhead line easements except under the most extreme circumstances.


- camping
- construction of houses, out buildings, pergolas or other substantial structures
- installation of fixed plant or equipment
- storage of flammable materials
- storage or use of explosives
- placing of garbage, refuse or fallen timber
- planting trees which will encroach upon the clearances specified in Drg S1-4-1-4
- excavation within 5 m of any overhead line structure
- placing any obstruction within 5 metres of any part of a structure
- installation of a swimming pool or spa
