The Official Manager provided an opportunity for members of the gallery to ask questions.

Q: Ian Abbott of Farrar asked "In relation to the carparking fees that were not present in the Technical Quarterly Report, will there now be a report based on the income expenditure of the carparking fees or will that now wait until the next quarterly report?"

The Official Manager took the question on notice.

Q: Ian Abbott of Farrar asked "Will there be an adjustment in terms of the next quarterly financial review of the income statement of the carparking based on the fact that there will not be a multideck carpark?"

The Official Manager stated that there is an income and expected expenditure associated with it and that there will be a quarterly review of the financial statements.

Q: Ian Abbott of Farrar asked "What is the current action of the NT Government for the bore water pipeline located in Zuccoli?"

The Chief Executive Officer responded that the Council is currently in negotiations with the Northern Territory Government to resolve issues of aquifer management in that area. Council is working towards an Aquifer Management Plan that will allow the Council to manage the aquifer, and have an undertaking from the Northern Territory Government that, should successful management of that aquifer be achieved, they will be providing the bore that was promised to the Council some years ago.
