My question relates to the Palmerston City Council's duty under the Local Government Act 2019 (NT), which specifically states at ss 22(1)(e)-(f) that the functions of council include "to provide for the interests and well-being of individuals and groups within its area" and "to carry out measures to protect its area from natural and other hazards and to mitigate the effects of such hazards".

Question

Contrary to what one might think, Councils are actually required by statute to be concerned about broader issues than simply the administration of local roads, public libraries and waste management.

The NT Government is proposing to build a petrochemical and gas processing facility at Middle Arm, a proposal which is currently the subject of a Federal Senate Inquiry.

Expert submissions to that Inquiry reveal that the development, were it to go ahead, would place the constituents of Palmerston at increased risk of health complications from air pollution, including asthma and leukemia, as well as posing other risks for the future viability of Palmerston as a city, due to flow-on effects from climate change.

My question is: How does Council intend to protect its constituents from the "natural and other hazards" that are predicted to stem from the proposed development at Middle Arm?
